Update on NYS HERO Act Requirements for Employers

Last week, Governor Hochul announced that the Commissioner of Health has designated COVID-19 as a highly contagious communicable disease that presents a serious risk of harm to public health. Under the New York State HERO Act, employers are now required both to adopt and implement a workplace safety plan for protection from airborne infectious diseases. To assist employers, the state has developed a model Airborne Infectious Disease Exposure Prevention Plan that can be adopted and put into place by employers. The HERO Act requirements will apply to any psychiatric practice that pays an individual who performs duties and services for the practice on a regular basis, regardless of whether the individual receives a W-2 or 1099 from the practice. A copy of the practice's Prevention Plan must be distributed to all employees.

One exception to the mandatory requirements of the HERO Act is if an employer is already subject to Emergency Temporary Standards issued by the federal Occupational Safety and Health Administration (OSHA) in response to the COVID-19 pandemic. The OSHA standards generally apply to workplaces in the healthcare setting, **however** exemptions apply for (i) non-hospital ambulatory care settings (e.g., office or other outpatient settings) where all non-employees are screened prior to entry and people with suspected or confirmed COVID-19 are not permitted to enter and (ii) telehealth services are performed in a

setting where no direct patient care occurs.

In this case, if a healthcare provider is exempt from the OSHA standards, it must comply with the requirements of the NYS HERO Act. In light of the OSHA exemptions listed above, it appears that many NYSPA members (if they are also employers) may be exempt from the OSHA standards and should take steps to comply with the HERO Act as soon as possible. Members may wish to consult with their legal counsel to confirm which standard may apply to their practice.


